



PRIVACY POLICY

This privacy policy discloses the privacy practices for Rhino Software (“RhinoFit”, “We”, “Us”, “Our”), RhinoFit’s website (“The Website”), and its associated domains. This privacy policy applies solely to information collected by the marketing web site (www.rhinofit.ca) and the application website (my.rhinofit.ca). This is notice of the following:

1. What personally identifiable information is collected from you through The Website, how it is used, and with whom it may be shared.
2. What choices are available to you regarding the use of your data.
3. The security procedures in place to protect the misuse of your information.
4. How you can correct any inaccuracies in the information.

Information Collection, Use, and Sharing

We are the sole owners of the information collected on this site. We only have access to collect information that you voluntarily give us via direct form entry, client data entry, email, or other direct contact from you. We will not sell, lease, or rent this information to anyone.

We will use your information to respond to you regarding the reason you contacted us and your information will be used by The Website to maintain data records to be used by paying clients of the RhinoFit Website. We will not share your information with any third party outside of our organization, other than as necessary to fulfill your request, e.g. to ship an order or process a payment.



Unless you ask us not to, we may contact you via email in the future to tell you about specials, new products or services, or changes to this privacy policy.

Your Access to and Control Over Information

If you are a paying client of RhinoFit, you may not opt out of future contacts from us. If you are a member of a paying client, you may opt out of contact from our client by contacting them directly. If you are a trial user or a non-paying client, you may opt out of any future contacts or communication from us at any time unless you have a contract with us stating otherwise. You can do the following at any time by contacting us via the email address or phone number given on our website:

- See what data we have about you, if any.
- Express any concern you have about our use of your data.

Security

We take precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline.

Wherever we collect sensitive information (such as credit card data), that information is encrypted and transmitted to us in a secure way. You can verify this by looking for a closed lock icon at the bottom of your web browser, or looking for "https" at the beginning of the address of the web page. The Certificate should match the Website you are on (my.rhinofit.ca will have a certificate issued to my.rhinofit.ca).

While we use encryption to protect sensitive information transmitted online, we also protect your information offline. Only employees who need the information to perform a specific job (for example, billing or customer service) are granted access to processing



or other sensitive information. The computers and servers that store personally identifiable information are kept in a secure environment.
